PRIVATE MARKETS 2.0

Quantitative research has benefitted investors in capital markets for decades, from hedge funds to smart beta.

This time has come for private markets.

At the crossroad of academia and industry, we are a quantitative team with a focus on **private asset pricing and market dynamics.**

We create model-driven products and solutions with practical applications for investors in need of better data so they can decide how to deploy capital in private equity and infrastructure markets while **managing risk and benchmarking performance.**

We are **not a repository of contributed information** provided by a limited sample of market participants.

Instead, we collect data directly from private firms and markets and use advanced financial modelling, statistics and machine learning to produce **scientific results fit to make investment decisions**.

We do so **transparently**, using models that are fully documented.

WHY QUANT RESEARCH?

In 2024, **private asset investing represents trillions of dollars** of allocations and requires representative and robust market data to measure value and risk.

But private markets themselves generate little raw data, and most of it is not public. **Quantitative research, including machine learning techniques, is the way for private market investors** to access the information they need.

WHY QUANT RESEARCH?

The absence of high frequency transaction data in private markets means that **almost every reported value is based on a model.**

The **actual choice for investors in private assets** is not between taking a quantitative approach or not.

The choice they face is **between using good data and quantitative methods or bad ones.** The difference is a matter of fiduciary duty.

VALUE PROPOSITION

Private markets provide investors with information through transaction prices that are **always noisy and biased**.

Using advanced, scientific models and the best data available, quantitative research can de-noise and correct biases in the data to provide investors with **access to robust and representative market information**.

VALUE PROPOSITION

With our technology and unique access to private market information, we produce data that serves as a *starting point* in private investing.

1. Asset Valuation: we offer robust, representative and customisable data to **anchor private asset valuations to market conditions.**

2. Market Dynamics: we offer a suite of **private market indices and customisable benchmarks** to track market levels and risk.

WHAT IS THE **ANCHORING** OF PRIVATE ASSET VALUATIONS?

The market value of (private) assets is determined by a combination of market (systematic) and asset-specific (idiosyncratic) factors.

Anchoring consists of creating a *customised (risk-adjusted) starting point* for the valuation of the asset that captures its exposure to private market risk at the time of valuation, thanks to an explicit model of market risk.

Once an asset value is **anchored to private market conditions**, it can be adjusted to capture idiosyncratic factors.

WHAT IS AN INDEX OF PRIVATE MARKET DYNAMICS?

The fair market value of private assets changes continuously with supply and demand and the state of the economy, but these **dynamics are not captured by the traditional financial appraisals** of private assets.

An index of private market dynamics uses a robust asset pricing model to produce thousands of shadow prices at each point in time and compute a return index of these prices. **Because the model is robust* the average value is accurate, and the index captures the dynamics of the asset class.**

**The average predicted price in each segment is the very close to the average observed price.*

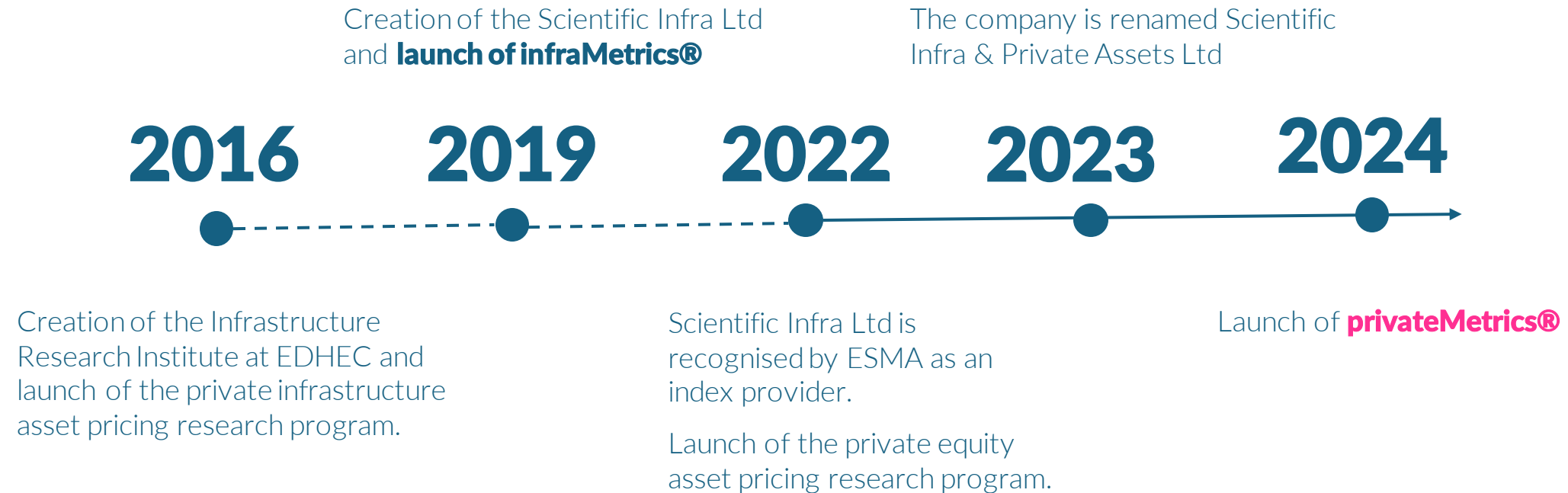
